1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

The Moirang College is a college which is affiliated to the Manipur University. Therefore, the college follows the curriculum designed by MU. The college tries its best to transact the framed curriculum through teaching and learning process in the classrooms and laboratories. Talks, seminar and other curricular activities are organized in the college from time to time. For the effective implementation of the curriculum, the Academic Council of the College makes an action plan for each academic session with the cooperation of the teachers. The teachers prepare lesson plans for the curriculum delivery in accordance with the academic calendar prepared by the Academic Council. Besides the classroom activities, the college organizes study tours to gain practical experience. Teacher in-charge of the tour helps and guides the students in executing the purposes of tour. Presentation and preparation of field report are made for fulfilling the course. For the effective academic exercise, the college makes action plan through academic council. The Academic Council has an Academic Officer who coordinate with the HODs of various departments in carrying out the action plan. The delivery of the curriculum is planned as follows: 1. The Academic Officer prepares an academic calendar and time table incorporating the government holidays as well as examination schedules prepared by MU. 2. The HODs in consultation with the faculty members of each department prepared the workloads of different faculties for the effective delivery and implementation of the curriculum. 3. Provisions are made for taking extra classes for the loss of classes due to bandhs, strikes and natural calamities. Remedial classes and tutorials are also arranged for slow learners. 4. Great cares are taken so that the syllabus is covered before the commencement of semester examination. 5. Curriculum delivery and implementation are strictly monitored by the Academic Officer. The college tries to achieve its planned target for curriculum delivery by conducting meetings of the academic council and find out the shortfall and policies by addressing the problems faced for smooth delivery.

On the day of induction programme conducted at the beginning of the academic year, the IQAC Coordinator and Examination Controller of the College delivered lecture about the rules and regulation of the Continuous Internal Evaluation System to make the students aware about the idea of CIES. The college conducted both the internal and external examination. Internal examination carries 30 percent of marks and 70 percent of marks are reserved for external examination. Thus, the college has an examination committee which deals with the reforms regarding CIES. • Schedule of Internal Assessment Examination are displayed on the Academic calendar and the same is communicated to the students in advance.

• In order to support and encourage the students, solved paper of previous

university question are provided to the students prior to the examination. • In a semester at least one internal assessment is to be conducted and marks scored is taken into account. • Students who failed to attend the internal examination on reasonable and genuine grounds such as active participation in extracurricular activities, sports, NSS and NCC activities are given second chance to appear the examination on another date fixed by the HODs of the concerned department. • After the examination and evaluation of papers, meetings between the faculty members, parents and students are held to discuss the progress and performance of the students which helps to make the parents aware of their wards.

The institute prepared an academic calendar to provide information of all the programme to the students and teachers. The academic calendar is prepared by the members of the academic council and head of the institution. Not only the examination related matters, the academic calendar constitute the other related matters. The procedures of the admission for the new session are also elaborated in the academic calendar. #### 8. Future Plans of Actions for Next Academic Year

Introduction of blended learning: Due to the outbreak of Covid-19 pandemic and the measures taken up by the administrative department such as lockdown, many serious effects were faced on teaching and learning process of the institution. Realizing such a situation in present and future, our institution decided to introduce blended mode of teaching - learning process. It will bring more beneficial to both teachers and students of the institution while transaction of curriculum. Also, the college decided to provide technical knowledge and support to the faculties for conducting online classes. Plan for Leasing out of College Assets in PPP Model: Moirang college has many untapped resources such as water body and huge ground. As an income generation purpose, Moirang College Planning Board decided to attract the Private partners in some of its untapped resources. After considering with all stakeholders the College Authority decided to lease out its water bodies covering an area of 2 acres to a person. The College could earn a sum of Rs.50, 000 per annum from this sector. In another case, the College Canteen is also to be privatized. The Authority is also expecting a sum of Rs.50, 000 per annum from it. Further, college Authority plan to sign a memorandum of understanding between an Athletics Academy. The Academy is to be permitted to use

the indoor hall and the College Ground. In return, the Academy will provide all kinds of basic training to our students.
